#### **The SAR Process**

- Status Assessment: COSEWIC -Endangered (November 2010)
- Legal Listing: Species at Risk Act (SARA) - June 2012
- Recovery: Recovery Strategy/ Action Plan - June 2013, will not be met

## **SARA Legal Listing**

- Protection: "no person shall kill, harm, harass, capture, take, possess, collect, buy, sell or trade"
- *Residence*: not applicable to plants
- Applies to: Federal lands (e.g. national parks, National Wildlife Areas, military bases)

#### Protection

- Provinces/Territories: provide "effective protection and enforcement"
- AB: WBP listed under Wildlife Act but no regulations to protect; policy & planning guidelines; Recovery Strategy in prep
- BC: WBP not listed; policy & planning guidelines, effectiveness not clear

#### **Recovery Strategy**

 Recovery Team: led by EC, possibly w/ AB, BC, CFS & Parks Canada members

- Objective: downlisting from Endangered to Special Concern or Not-at-Risk
- If not possible, ensure long term persistence, as best possible

## **Recovery Strategy**

- 1. Determine if recovery is "technically and biologically feasible"
- Can reasons for listing be remedied?
- 2. If not feasible, prepare RS/AP w/ reasons why not feasible
- identify Critical Habitat (survival)
- 3. If feasible, prepare Recovery Strategy/Action Plan

### **Recovery Strategy**

• Recovery Goal: population & distribution goals re COSEWIC assessment criteria

 Recovery Objectives: measurable objectives for next 5 years

#### **Critical Habitat**

- "habitat necessary for survival or recovery & is identified in the recovery strategy or action plan"
- Critical Habitat is a means to meet population & distribution goals/ objectives

## **Recovery Strategy Contents**

- 1. identify threats to survival & habitat consistent w/ COSEWIC assessment
- identify Critical Habitat (to extent possible) w/ examples of destructive activities
- if info inadequate, schedule of studies,
  do in Action Plan (w/ completion date)

## **Ministerial Permit (SARA)**

 "authorizing an activity affecting a listed species, or its critical habitat"

when:

- research on conservation by qualified persons
- activity benefits or enhances survival and Minister is of the opinion that.
- all reasonable alternatives considered, use best
- all feasible measures taken to reduce impact on species or Critical Habitat
- activity will not jeopardize survival or recovery

#### **Restoration Activities**

- Prescribed fire: habitat restoration
- Plant: rust-resistant seedlings
- Research: genetic resistance, seed/gene banking
- Research: assisted migration (climate change)
